What is the Annual Fund?

The OLPH Annual Fund is a planned, coordinated, concentrated effort undertaken each year to raise unrestricted gifts to help OLPH School ensure its viability, reach its full potential, as well as maintain and enhance the excellence of its programs.

Why does OLPH School have an Annual Fund?

We strive to keep tuition affordable. As a result, there is a gap between the cost of educating each student and tuition. Annual giving decreases this gap and positively impacts every part of the school from classroom enhancements, state-of-the-art technology and financial aid. A gift to the Annual Fund is tax-deductible and tuition is not.

Are all parents asked to give?

Yes. Since the success of the Annual Fund relies on 100% participation, all parents are asked to give at the most generous level possible.

Who else gives?

Every member of the OLPH School community is asked to participate in the Annual Fund. This includes faculty/staff, Board members, parents, grandparents, alumni and friends of the school.

When will I be asked to give?

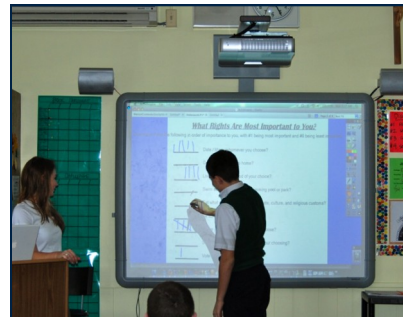
Starting on November 1, we are asking parents to make their Annual Fund pledge or donation. Final payment to the Annual Fund is due by June 15th, 2011. Remember, if you would like to receive your tax deduction in 2011, you must submit your payment by December 15th, 2011.
